4. Items for Discussion

4.1 Statistics on resident health, age profiles, transport, public health, primary care & therapies:

David Leech agreed to provide statistics for the abovementioned before the next scheduled meeting. Gareth Cook will assist in collating the data sets needed.

The Committee agreed it would concentrate its initial efforts on assisting residents to perform online tasks which mean they would not have to visit or call their doctor's surgery for things such as ordering medicines and booking appointments online. This would take place at The Hwb. Doing so would also serve to help with loneliness, as regular weekly sessions could be set aside to provide a drop-in service which would include the opportunity for refreshments and company with others accessing and providing the service.

Data provided by David Leech should help to determine residents needs and point to what further services could be offered to expand the initiative.

Ways to survey groups were discussed which could include accessing Hwb users, local church groups and residential homes such as Glaslyn Court.

4.2 Community Capacity Builders:

David Leech explained that Community Capacity Builders can be called upon. Their task will be to go to the identified groups and discuss how the service could be used once need is identified. They could also explore what other services residents feel would be of benefit to expand the service.
