5. Presentations & Representations

5.1 James Llewellyn PCSO and Hannah Yates PCSO, Gwent Police

PCSO James Llewellyn advised members that the latest crime report has not yet been shared but will be in due course.

Members were advised that PCSO Llewellyn now covers Llanyrafon, Ponthir and Coed Eva, and that a police surgery has been arranged with Cllr D Williams at 10am on 24th September at Llanyrafon Methodist Church, inviting members to share questions, concerns and receive crime prevention advice, and was advised the surgery is open to residents who reside both within and outside the Llanyrafon wards. Members were also advised that a speed operation has recently been conducted on Llanfrechfa Way, and stats had been shared with members.

Members queried how Gwent Police will support residents with upcoming festivities and was advised that for any residents who don't wish to celebrate Halloween, posters will be available to be delivered or can be downloaded online. An increased police presence is also expected over the Christmas period including monitoring shoplifting and providing advice on crime prevention.

Members were advised to contact PCSO Alex Rouf regarding arrangement of a police surgery within Croesyceiliog. The PCSO's were thanked for attending the Family Fun Day which was enjoyed by families, as well as the Full Council meeting, and members announced that they look forward to receiving a crime report shortly.

5.2 Mark Thomas TCBC – Neighbourhoods and Environment

Mark Thomas and Mike Sweeney introduced members to their presentation, Flood Risk in your Community. Members were advised that the purpose of the presentation was to highlight Torfaen Council's ambitions to work with the Community Council and in particular promote flood risk awareness and resilience. The local flood risk strategy outlines the council's ambitions which aim to achieve objectives to work collaboratively with communities as a shared approach to identify areas of risk, communicate risk, and provide skills to engage with the Borough Council to raise awareness and resilience to prepare and prevent flood risk within high-risk areas.

The council's actions to prepare for flooding include monitoring and maintenance of culverts, and providing a new development, flood sacks which work in the same was as sandbags but are more resilient, flat packed so easily transportable and have been trialled to be used to divert water courses, as well as creating a barrier within doorways and gateways, providing a dual use.

Members questioned the council's schedule of drain cleaning and was advised that the schedule is currently behind schedule due to several reasons, but that equipment and the maintenance team have been increased, and that areas at increased risk of flooding are prioritised.

Mark and Mike advised members that a community flood action group would provide an opportunity for community members to work with TCBC collaboratively to address the council's objectives to spread awareness, prepare for and take action during a flood event.

Cllr S Matthews raised concerns regarding the effectiveness of historical bunds, sewage leaks within the Afon Llwyd and local allotments which have flooded in previous storms. Mike Sweeney suggested arranging a site meeting to discuss the bunds within the area, and assured members that previous concerns raised by the Community Council relating to sewage and allotment flooding had been reported to the relevant officers, but that the items could also be discussed during a site meeting to discuss any areas of flood risk concern, as the information could be beneficial.

Members thanked the Torfaen Officers for their presentation and agreed the Clerk would be in contact to arrange a site visit to further discuss local flood risk.
